

It was well invited that our law college is situated along with other college and Departments and if complaint of grievance in the nature of eve teasing reported then committee has all the powers and it may transfer the same matter to the concerned college or department. It is left to the principal and it was also well accepted that, after reporting the grievance both the parties should give there grievance before the principal or any other faculty member at the primary stage.
