THE ELIGIBLE PERSONS FOR FREE LEGAL SERVICE UNDER THE LEGAL SERVICE AUTHORITY.

Under the Legal Service Authority Act, 1987, It states that, those persons who have annual income of less than the amount prescribed by the respective State Government, if the case is before any court other than the Supreme Court, and less than Rs. 5 Lakhs, if the case is before the Supreme Court, are **eligible** for free legal aid.

THE FUNCTIONS OF LEGAL SERVICE AUTHORITY


To Conduct Legal Aid Programmes for the Rural Development of the of the Society.

In 1987 Legal Services Authorities Act was enacted to give a statutory base to legal aid programmes throughout the country on a uniform pattern. This Act was finally enforced on **9th of November, 1995** after certain amendments were introduced therein by the Amendment Act of 1994.

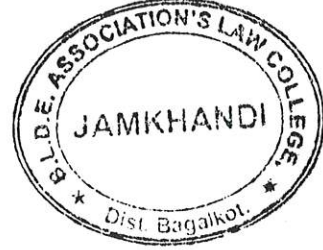
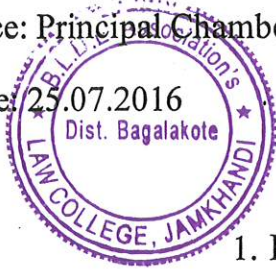

The faculty members were well accepted that, the Legal Aid and Legal Awareness camps should be organised with the permission of the Principal and

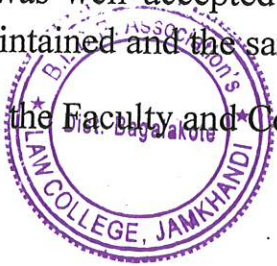
