1. Capitation fee in any form should not be collected.
2. The College shall not seek any financial assistance in the nature of
grant-in-aid from the Government and shall strictly function on "No
Grants for ever" basis.
3. The College shall not infringe upon the norms and standards prescribed
by the BCI, Karnataka State Law University and the Government from
time to time.
4. Admission of students shall be strictly in accordance with the regulations
of the Karnataka State Law University and the BCI.

5. The Principal and teaching staff of the College shall possess the requisite qualifications in law as stipulated by the Bar Council of India. The college shall not make any admissions or start imparting education in law before obtaining approval from the BCI as prescribed in Rule 14(1), (2) and (3) (Rules of Legal Education, Chapter III of Part IV) of the Bar Council of India Rules.
6. The college, before admitting students to a course, shall send to the Principal Secretary to Government, Law Department and the Registrar, Karnataka State Law University, a copy of the approval documents issued to it by the BCI. Deviation of any sort will be viewed seriously and Government retains the right to unilaterally cancel the permission granted to the college.
7. The College should follow the Statutes/Rules/Regulations and orders passed by the Karnataka State Law University from time to time in the interest of Students/Teachers/other employees of the College. The College should, under no circumstance, violate the eligibility criteria or exceed the intake of students prescribed in the affiliation orders of the University and shall fulfill all the conditions imposed by the LIC.
8. The college should follow the rules of the University in admitting 50% of the students under University quota (wherever applicable) with the fees fixed by the University from time to time and without charging any fee or amount over and above the fees fixed by the University.
9. The Management of the College has to note the Supreme Court order dated 13.8.1997 in Visakha Vs. State of Rajasthan with regard to any act of violence or sexual harassment of women at College/Work place by any student/ person including faculty which is a cognizable offence. Indulgence in such activities shall render liable for cancellation of admission and also render liable for punishment of such student/person. Further, the College/Management should undertake to establish a Complaints Committee for the abatement of the above offence as per the directions of the Supreme Court.
10. The College shall undertake to conduct the courses to the best advantage of the students' development. The Principal/Management should treat the Students/Teaching community courteously during their stay in the college.
11. The College shall not withhold the marks cards/transfer certificates and other documents of the students unnecessarily and no additional amount, save for the fees prescribed by the University shall be demanded for the same.

4. Admission of students shall be strictly in accordance with the regulations of the Karnataka State Law University and the BCI.

5. The Principal and teaching staff of the College shall possess the requisite qualifications in law as stipulated by the Bar Council of India. The college shall not make any admissions or start imparting education in law before obtaining approval from the BCI as prescribed in Rule 14(1), (2) and (3) (Rules of Legal Education, Chapter III of Part IV) of the Bar Council of India Rules.
6. The college, before admitting students to a course, shall send to the Principal Secretary to Government, Law Department and the Registrar, Karnataka State Law University, a copy of the approval documents issued to it by the BCI. Deviation of any sort will be viewed seriously and Government retains the right to unilaterally cancel the permission granted to the college.
7. The College should follow the Statutes/Rules/Regulations and orders passed by the Karnataka State Law University from time to time in the interest of Students/Teachers/other employees of the College. The College should, under no circumstance, violate the eligibility criteria or exceed the intake of students prescribed in the affiliation orders of the University and shall fulfill all the conditions imposed by the LIC.
8. The college should follow the rules of the University in admitting 50% of the students under University quota (wherever applicable) with the fees fixed by the University from time to time and without charging any fee or amount over and above the fees fixed by the University.
9. The Management of the College has to note the Supreme Court order dated 13.8.1997 in Visakha Vs. State of Rajasthan with regard to any act of violence or sexual harassment of women at College/Work place by any student/ person including faculty which is a cognizable offence. Indulgence in such activities shall render liable for cancellation of admission and also render liable for punishment of such student/person. Further, the College/Management should undertake to establish a Complaints Committee for the abatement of the above offence as per the directions of the Supreme Court.
10. The College shall undertake to conduct the courses to the best advantage of the students' development. The Principal/Management should treat the Students/Teaching community courteously during their stay in the college.
11. The College shall not withhold the marks cards/transfer certificates and other documents of the students unnecessarily and no additional amount, save for the fees prescribed by the University shall be demanded for the same.

1. The inspection team inspected the above proposed law college on 11.7.2003 at about 4.30 p.m. At the time of inspection, the members of Governing body of the college, the large number of local advocates and the Principal of Commerce, Arts and Science college run by the BLDE Association were present and they brought to the notice of the inspection team the following facts.

a). Jamkhandi is a Sub divisional Headquarter in newly formed Bagalkote district. This is growing and developing very fast as many of the nearby riparian villages have been submerged in the backwaters of Upper Krishna project which paved way for setting up of many rehabilitation centres around this city, Besides, there are Muthol and Bilagi taluks which are coming under the Sub divisional jurisdiction of Jamkhandi Sub division, Apart from these, there are two twin big municipal towns. Thus, Jamkhandi has become a prominent centre place for education.

b). Though, there are big rivers passing through this Jamkhandi Sub Division, major part of this Sub division remained backward in every respect. In this background, an Association called BLDE Association came into being in the year 1910. In a short span, this registered Association under the provisions of Societies Registration Act has established as many as 48 educational institutions including Engineering and Medical institutions. This BLDE Association has got sufficient infrastructures to run any educational institution including non profitable college of law because this Association is already running Arts, Science and Commerce colleges and each institution is running in a different spacious separate building constructed in a big campus in Jamkhandi town itself. The statements of account of these institutions show the annual budget of Rs.3 crores 52 lakhs at their disposal. This BLDE Association has already constructed a separate building exclusively for law college in the college campus and the same is having two class rooms, one library hall, one ladies' room one Principal's chamber cum office and required toilets at present. There is plenty of space available to put up additional constructions in the existing building. At the time of inspection, the members of the Governing body of BLDE Association informed the team that the Association is prepared to abide by any condition to be fulfilled and they requested approval of affiliation for imparting law education in 5 years law course.

c) The Jamkhandi Town population at present is two lakhs apart from population of other two big taluks and two twin municipal councils. There are 12 pre-university colleges in these towns and taluks. The Jamkhandi town is 70 k.m. away from Chikkodi, 160 k.m. away from Belgaum, 100 k.m. from Bagalkote and 70 k.m. from Bijapur, where law colleges are running. The Jamkhandi is having one Civil Judge's court (Junior Division), one Civil Judge's court (Senior division), one Sub Divisional Magistrate Court apart from other revenue courts. The strength of the Bar Association of Jamkhandi town is 240 and many of them were present at the time of inspection.

d) The State Government of Karnataka by its proceedings dated 9.6.2003 accorded permission to start new law college in 5 years law course to the above Association with an intake of 80 students from the academic year 2003-2004 subject to several conditions and further the Karnataka University at Dharwar on the basis of recommendation of its Syndicate dated 12.3.2003 stated that it has no objection to accord sanction / affiliation if the Bar Council of India grants prior approval as required by Section 59(ii) of the Karnataka Universities Act of 2000.

2) In view of the above stated facts, we, the members of the inspection team are of the view that permission / approval of affiliation can be granted to the Bijapur Liberal Education Association to impart law education in 5 years law course initially for two years with an intake of 80 students from the academic year 2003 - 2004 with condition that the Association shall

- i) obtain required affiliation from the University concerned as required under Section 59 (ii) of the Karnataka Universities Act, 2000,
- ii) appoint a qualified Principal and Staff after observing required norms,
- iii) appoint qualified librarian in the similar way,
- iv) purchase law books, law journals required for 5 years law course.

The Association has to comply with the above conditions within two months from the date of communication of this approval.

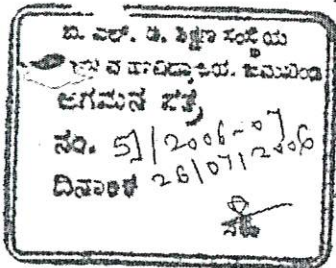



The above Law College was inspected by the Inspection Committee on 24.05.2006 which is affiliated to Karnataka University, Dharwad to impart legal education with an intake of 80 Students is being run by B.L.D.E. Associations, Bijapoor, Karnataka State. The earlier Inspection Committee inspected the above college on 11.7.2003 and the Legal Education Committee at its meeting held on 18th and 19th July 2003 granted temporary approval of affiliation with an intake of one section of 80 students for imparting five year law course and thereafter again inspected by another team and further extension of approval of affiliation for the academic year 2005 – 2006 was granted on the following conditions :

- (1) The management shall complete the construction of three Additional rooms in the existing building as proposed.
- (2) One Moot Court hall to be arranged from out of the class Rooms.
- (3) Appoint permanent Principal, 2 additional law teachers and One pre law teacher immediately.
- (4) Provide more law books to library.

(1) The Management shall complete the construction of three Additional rooms in the existing building as proposed.

Till now, there are only 3 Class rooms are found. However, the College Authorities have shown in the First floor on the rear side of the existing building a semi-finished structure which consists of two class rooms and one Moot Court hall.

On verification of the records and on physical verification, the Inspection Committee found still there is only In-charge Principal with qualification of B.A.L.L.M. and 3 other full time lecturers for L.L.M. course are also found. However none of them are paid U.G.C. scale or scale prescribed by the State Government. There are 5 part-time lecturers to teach 3 year law course. They are also not paid according to the norms and Rules of the Bar Council of India and all the staffs are paid only by cash and not through cheque.

- (4) Provide more law books to library.

On verification it is found that the books worth about Rs.90,000/- have been purchased during the year 2005-2006. However, the existing books that are found in the library are not sufficient for the students.

BUILDING:

The buildings where the law college is situated consist of, in the ground floor two class rooms, one library, one staff room, one Lady's common room with separate toilet facilities for boys and girls.

In the first floor there is one Principal room, one office room and one class room.

On considering the above aspects the Inspection Committee is of the view to grant temporary approval of affiliation to the above college only for one year for the academic year from 2006 to 2007 only, to impart legal Education in 5 years LLB Degree course with an intake of 80 students only subject to the following conditions :

- (1) The Management shall complete the construction of 3 additional class rooms within six months.

1. The inspection team inspected the above proposed law college on 11.7.2003 at about 4.30 p.m. At the time of inspection, the members of Governing body of the college, the large number of local advocates and the Principal of Commerce, Arts and Science college run by the BLDE Association were present and they brought to the notice of the inspection team the following facts.

a). Jamkhandi is a Sub divisional Headquarter in newly formed Bagalkote district. This is growing and developing very fast as many of the nearby riparian villages have been submerged in the backwaters of Upper Krishna project which paved way for setting up of many rehabilitation centres around this city, Besides, there are Muthol and Bilagi taluks which are coming under the Sub divisional jurisdiction of Jamkhandi Sub division, Apart from these, there are two twin big municipal towns. Thus, Jamkhandi has become a prominent centre place for education.

b). Though, there are big rivers passing through this Jamkhandi Sub Division, major part of this Sub division remained backward in every respect. In this background, an Association called BLDE Association came into being in the year 1910. In a short span, this registered Association under the provisions of Societies Registration Act has established as many as 48 educational institutions including Engineering and Medical institutions. This BLDE Association has got sufficient infrastructures to run any educational institution including non profitable college of law because this Association is already running Arts, Science and Commerce colleges and each institution is running in a different spacious separate building constructed in a big campus in Jamkhandi town itself. The statements of account of these institutions show the annual budget of Rs.3 crores 52 lakhs at their disposal. This BLDE Association has already constructed a separate building exclusively for law college in the college campus and the same is having two class rooms, one library hall, one ladies' room one Principal's chamber cum office and required toilets at present. There is plenty of space available to put up additional constructions in the existing building. At the time of inspection, the members of the Governing body of BLDE Association informed the team that the Association is prepared to abide by any condition to be fulfilled and they requested approval of affiliation for imparting law education in 5 years law course.

c) The Jamkhandi Town population at present is two lakhs apart from population of other two big taluks and two twin municipal councils. There are 12 pre-university colleges in these towns and taluks. The Jamkhandi town is 90 k.m. away from Chikkodi, 160 k.m. away from Belgaum, 100 k.m. from Bagalkote and 70 k.m. from Bijapur, where law colleges are running. The Jamkhandi is having one Civil Judge's court (Junior Division), one Civil Judge's court (Senior division), one Sub Divisional Magistrate Court apart from other revenue courts. The strength of the Bar Association of Jamkhandi town is 240 and many of them were present at the time of inspection.

d) The State Government of Karnataka by its proceedings dated 9.6.2003 accorded permission to start new law college in 5 years law course to the above Association with an intake of 80 students from the academic year 2003-2004 subject to several conditions and further the Karnataka University at Dharwar on the basis of recommendation of its Syndicate dated 12.3.2003 stated that it has no objection to accord sanction / affiliation if the Bar Council of India grants prior approval as required by Section 59(ii) of the Karnataka Universities Act of 2000.

2) In view of the above stated facts, we, the members of the inspection team are of the view that permission / approval of affiliation can be granted to the Bijapur Liberal Education Association to impart law education in 5 years law course initially for two years with an intake of 80 students from the academic year 2003 - 2004 with condition that the Association shall

- i) obtain required affiliation from the University concerned as required under Section 59 (ii) of the Karnataka Universities Act, 2000,
- ii) appoint a qualified Principal and Staff after observing required norms,
- iii) appoint qualified librarian in the similar way,
- iv) purchase law books, law journals required for 5 years law course.

The Association has to comply with the above conditions within two months from the date of communication of this approval.

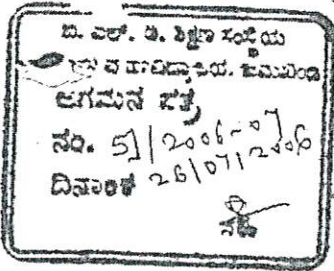



INSPECTION REPORT

The above Law College was inspected by the Inspection Committee on 24.05.2006 which is affiliated to Karnataka University, Dharwad to impart legal education with an intake of 80 Students is being run by B.L..D.E. Associations, Bijapoor, Karnataka State. The earlier Inspection Committee inspected the above college on 11.7.2003 and the Legal Education Committee at its meeting held on 18th and 19th July 2003 granted temporary approval of affiliation with an intake of one section of 80 students for imparting five year law course and thereafter again inspected by another team and further extension of approval of affiliation for the academic year 2005 – 2006 was granted on the following conditions :

- (1) The management shall complete the construction of three Additional rooms in the existing building as proposed.
- (2) One Moot Court hall to be arranged from out of the class Rooms.
- (3) Appoint permanent Principal, 2 additional law teachers and One pre law teacher immediately.
- (4) Provide more law books to library.

(1) The Management shall complete the construction of three Additional rooms in the existing building as proposed.

Till now, there are only 3 Class rooms are found. However, the College Authorities have shown in the First floor on the rear side of the existing building a semi-finished structure which consists of two class rooms and one Moot Court hall.

(2) One Moot Court hall to be arranged from out of the class rooms.

One Moot Court hall is under construction on the rear side as stated above.

On verification of the records and on physical verification, the Inspection Committee found still there is only In-charge Principal with qualification of B.A.L.L.M. and 3 other full time lecturers for L.L.M. course are also found. However none of them are paid U.G.C. scale or scale prescribed by the State Government. There are 5 part-time lecturers to teach 3 year law course. They are also not paid according to the norms and Rules of the Bar Council of India and all the staffs are paid only by cash and not through cheque.

- (4) Provide more law books to library.

On verification it is found that the books worth about Rs.90,000/- have been purchased during the year 2005-2006. However, the existing books that are found in the library are not sufficient for the students.

BUILDING:

The buildings where the law college is situated consist of, in the ground floor two class rooms, one library, one staff room, one Lady's common room with separate toilet facilities for boys and girls.

In the first floor there is one Principal room, one office room and one class room.

On considering the above aspects the Inspection Committee is of the view to grant temporary approval of affiliation to the above college only for one year for the academic year from 2006 to 2007 only, to impart legal Education in 5 years LLB Degree course with an intake of 80 students only subject to the following conditions :

- (1) The Management shall complete the construction of 3 additional class rooms within six months.

- (5) The college should continue to buy library books for Rs.50,000/- every year.
- (6) The B.L.D.E. Association has to transfer a corpus fund of Rs.15,00,000/-(Rs.Fifteen lakh only) immediately infavour of B.L.D.E.Association's Law College to complete the construction of class rooms and Moot courts.

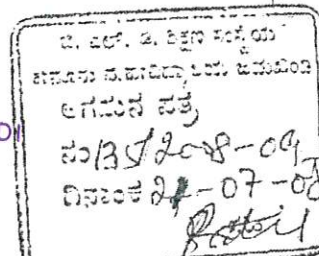



The college is situated on the top of the hill with beautiful atmosphere and greeneries. Below the foot of the hill, they have swimming pool with beautiful garden.

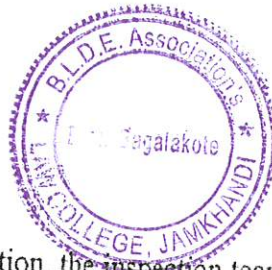
