

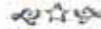

Sub : Affiliated colleges making their own rules unauthorisedly in contravention to existing rules - reg.

Ref : 1. Bar Council of India Rules 2008.
2.. KSLU Regulation and ordinance Rule 13.

It has come to the notice of the University that some of the affiliated colleges of KSLU are making their own rules with regard to minimum requirement of attendance, per subject, as 50%, whereas the minimum attendance requirement prescribed by the BCI and KSLU rules is 70%. Such of the colleges who make such rules unilaterally in contravention to the existing rules of BCI and KSLU, are clearly violating the mandatory requirements. The BCI or the KSLU has not authorized any colleges or bodies to formulate their own rules in such matters. If any college is found to create such rules unilaterally, will be putting their own students at risk of not making them eligible to attend the examinations. Hence, it is directed to all the Principals / Managements that the affiliated law colleges of KSLU should not make any rules or regulations in respect of attendance, admission, affiliation, course, syllabus, fee structure etc. in contravention to the existing rules of the BCI, KSLU, UGC, State / Central Government etc. Otherwise, such of the colleges who violate these guidelines will run the risk of losing affiliation and recognition by the University / State Government.

This should be strictly adhered to. All the Principals are hereby instructed to send a report by e-mail informing the University that they have not formulated any rules in violation or in contravention to the existing rules of BCI, KSLU etc. within a week from the date of receipt of this e-mail.
