





#### I AND II year (5 year course)


For the convenience of the 1st year students and for disseminating legal knowledge and to create curiosity in law, the following method can be adopted. They are,


Practical training for 1st year (5 year course) and 1 yr (3 year course)

1. Assignment on Social Evils can be given in the class room and presentation to be made.
2. Lectures on court functioning can be conducted titled as "A Day with an advocate or "A day with a Judge."
3. Police officials can be invited to talk on Traffic Rules, Police Act of 1869 etc for the maintainance of law and order in the society, Revenue officials can also be invited to talk on various social welfare schemes introduced by Karnataka Government.

#### III, IV and V Year and II AND III YEAR (3 years)

- i. Each student should attend an advocates office or firm for Internship for a period of 20 weeks in case of 5 years students, 12 weeks in case of 3 years.
- ii. Independent files are to be maintained and shall be monitored by the teacher.
