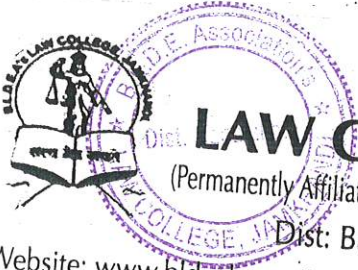

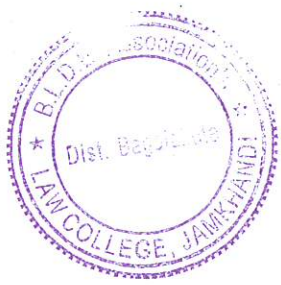

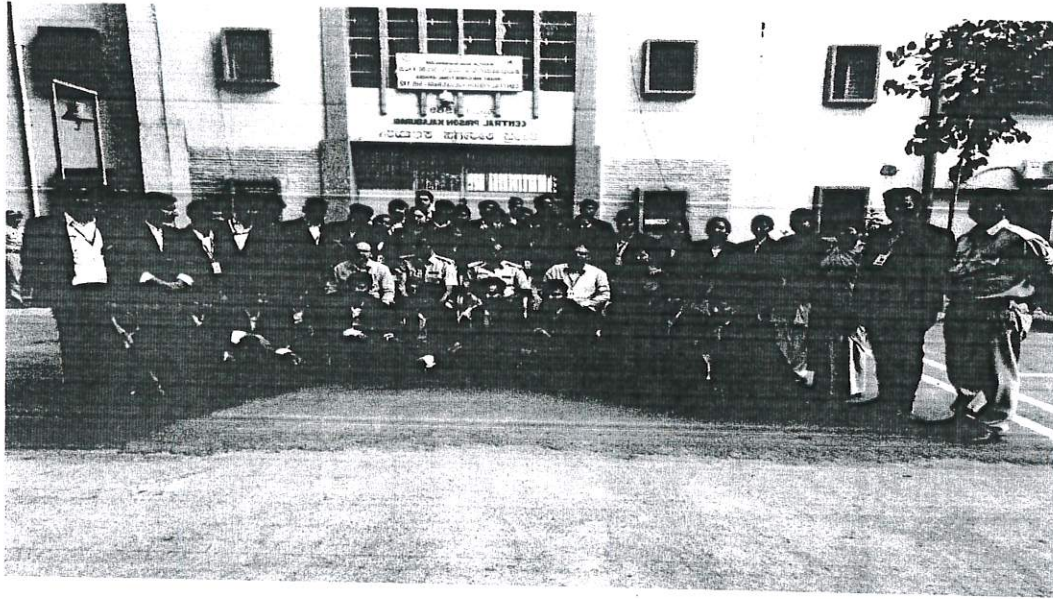

Students also got chance to interact with the jailor and they asked numbers of questions beginning with the myth behind prisons i.e. harassment with prisoners inside the jail to which the authority responded that there is no such concept to harass the prisoners. They told the prisoners are also human beings the only difference between the prisoners and the person staying outside the jail is that they have done something which is beyond and violation of law that is why are been kept inside the prison to improvise their bad behavior.

The Deputy Jailor also guided us on the procedures of FIR, Investigation, Trial. Students asked different questions pertaining to crimes, Human rights, fundamental rights, criminal behaviours, discrimination on the status of persons etc. Each-where there is bill boards on the walls containing the motivational and spiritual thoughts and quotes. The deputy jailor also imparted the knowledge relating to the facilities inside the premises of Jail. He also said that the Constitution of India is best followed inside the prison. He added persons from different religions, races, castes, creeds are living together inside the prisons and they are treated equally in every aspects. The jail campus is on continuous surveillance by CCTV Cameras.

The idea behind the visit was to acquaint the students with the jail manual in a practical manner. The students were told about the difficulties faced by prisoners when it came to getting legal aid and constraints of the jail authorities to facilitate their visit for the court hearing. Special kind of privilege is given to women like providing oil, Sanitary Napkins, cosmetics etc. The jailor discussed various provisions of Cr. P.C. including Sections 154, 167 etc. Apart from he discussed various case laws including K.M. Nanavati v. State of Maharashtra. Lastly, he added, DALSA is also working for the prisoners through its free legal aid services. They provide free legal service to the convicted person. After this discussion, session students were divided in two groups i.e. one of Boy and other is of Girls to visit the prison where the prisoners are being kept. Boys went to visit the Male department and Girls to Girls department of the jail. In Girls department of jail they saw the different varieties of facilities including Beauty Parlour, teaching room, worshipping room etc. The surrounding of jail was very neat and clean; many facilities are being provided to them for enjoying their life in a better way. In male department of jail there were numbers of facilities including recreational activities to encourage the prisoners to participate to foster their mental, physical and culture developments. There was a separate rooms for co-curricular activities including Music, painting etc.

### INFRASTRUCTURE OF JAIL

The infrastructure of Jail was further than the imagination. The Prison had a very sparkling environment with beautiful green garden appropriately maintained by Prisoners themselves. The manifest infrastructure includes:

1. **Hospital-** There is a separate building consisting of hospital for the prisoners. prisoners are provided round the clock medical attention in the Gulbarga Jail. For women prisoners there is a separate dispensary and a treatment Room, all managed by female

staff/prisoners. Various NGO's are also working with Prisoners and contributing towards medical services.

2. **Library-** The mission of a prison library is to make available educational and leisure resources to prisoners. This is in the form of books, newspapers, magazines, movies, and library programming. The reason behind the library is that this will aid in the rehabilitation process, and, most importantly, provide a means of flee and disruption so that prisoners stay out of trouble. "Idle hands are the devil's workshop in prison, and having a book in them is much better than a weapon." The books contained epics, stories, novels, philosophical items, law books, and different acts, which were in different languages. There were around 800 books available in the library. The timings for the library are 12.00 hrs to 16.00 hrs.

3. **Meditation Room-** For refinement, Yoga and meditation classes were started in with the help of various voluntary organizations in the Jail. Staff members are also encouraged, to attend meditation courses. This has helped many prisoners in changing their approach to life.

4. **Video Conferencing Room-** With the passage of time and development of technology this room helps the prisoner who is either sick or not in the condition to give his physical presence in the court. The prisoners can give his statements in the court by using this facility.

5. **Educational Activities-** Inside the Jail, there is an amazing facility for education. Educational activities are done with the help of Government resources, various NGO's participation and also from students of different colleges. The most important characteristic of providing education system in Jail is that educated prisoners voluntarily teach less educated prisoners.

The BLDE Association's Law College Jamkhandi, is the Esteemed educational Law institution situated in Jamkhandi, Talk Jamkhandi, District Bagalakot, State; Karnataka India. The students of the institution have visited the Forensic Laboratory which is situated in Kalaburagi, Karnataka.

**OBJECTIVES TO VISIT OF FORENSIC LABORATORY**

The Forensic Science Laboratory is responsible for **the examination and analysis of evidentiary materials** in areas including Chemistry, Arson, Firearms, Tool marks, Questioned Documents, Serology, Biochemistry, Trace Evidence, Latent Fingerprints, Imprints and Impressions, Instrumentation and DNA.

The above said subjects are Part of Advocacy; the students who are interested in the field of Criminal Law will get use of it. As the part of Criminal Law, Cr. PC, I.P.C, and Indian Evidence Act and for experimental practical purpose of the advocacy the institution generally provides all the necessary education by means of academic as well as practical.

**Importance of Forensic Science in Law**

The legal system clearly understands the role that forensic evidence plays in criminal trials. This is because there isn't much room for bias or discrimination while using scientific techniques and methods. This is why profiling of DNA and a variety of other forensic evidence are commonly recognized in courts around the world. Interestingly, the Chinese (650 A.D.) dates back to the first forensic technique ever used that involved finger and palm print recognition.

Forensic testimony is commonly used across the world for both convicting and pardoning suspects. Thus, forensic science labs have been mushrooming across the globe over the past few decades. In addition, Special Acts have been passed to enhance the delivery of forensic services in the US, Canada and Australia. This ensures greater certainty in the detection of crimes, and consequently, rates of conviction may increase. Such Acts place great emphasis on timely and high-quality crime scene management.

The forensic proof is often used for both defendants who have been convicted and acquitted. As a consequence, the number of crime laboratories throughout the world has increased significantly over the last couple of decades. Special acts have been implemented in the United States, Canada, Great Britain and Australia in order to improve the forensic status of criminals, and thereby enable convictions to increase. They stress the timely and quality

facts. The news media highlight the importance of forensic science but also focus on errors in locating and identifying in high profile cases.

Expert testimonials offer an important informational source in international criminal proceedings, and forensic expertise is no exception: the ad hoc trials and judgments have been based on findings from exhumations and examinations. While issues relating to the relationship between law and science have been explored within the domains of national judicial systems, the mixed court system presents a solid debate with new contexts. An officer with further forensic studies could be overconfident and unintentionally taint evidence, making it inadmissible. Instead, given the current lack of adequate collection of substantial evidence from the crime scene (if not trampled underfoot and completely ignored), proper training will be more likely to improve the situation rather than worsen it, if competent forensic science instructors are able to carry out it.

#### Conclusion

In the Indian case, greater focus was put on the use of these technologies in criminal investigations and trials. Commissions appointed on criminal justice reforms have affirmed that the introduction of crime detection technologies will enable the system to work efficiently. The related laws have been changed from time to time to make room for the use of forensic technologies in investigating and prosecuting crime. And yet, it can be argued that the regulations that need to be revised have current flaws. Also, due to their conservative approach, the courts are reluctant to rely on empirical evidence, or other inherent flaws in the evidence presented in court, which prevent them from relying entirely on it. Criminal justice system's primary motto is to have equal justice. The forensic proof is, no doubt, more credible than eye testimony.

Being a scientific method, forensic science is a boon to the criminal justice system. To progress, we need to overcome the existing flaws. Around the same time, there is a need to ensure that law enforcement and investigative agencies once again understand and use forensic science as a holistic problem-solving resource to their full potential. It is apparent that such a technique is incorporated within a context that enables an understanding of the input that a particular form of evidence may provide meaningfully in terms of sub-source, source, operation or offence-level proposals for a given collection of case-specific circumstances rather than restricting it to a one-dimensional reactive procedure. An interpreted means of evaluative monitoring of forensic science data pertinent to a specific case but retained in the context of that case where alternate solution propositions can be attended to and challenged correctly, works to fulfil this problem-solving prospects. Such a method has been developed by the Association of Forensic Science Suppliers among others.

As the above explanation states, The BLDE Associations Law College Jamkhandi students were so keen interested to visit the laboratory, students have taken the utilisation practical visit to the Laboratory along with faculty members.
