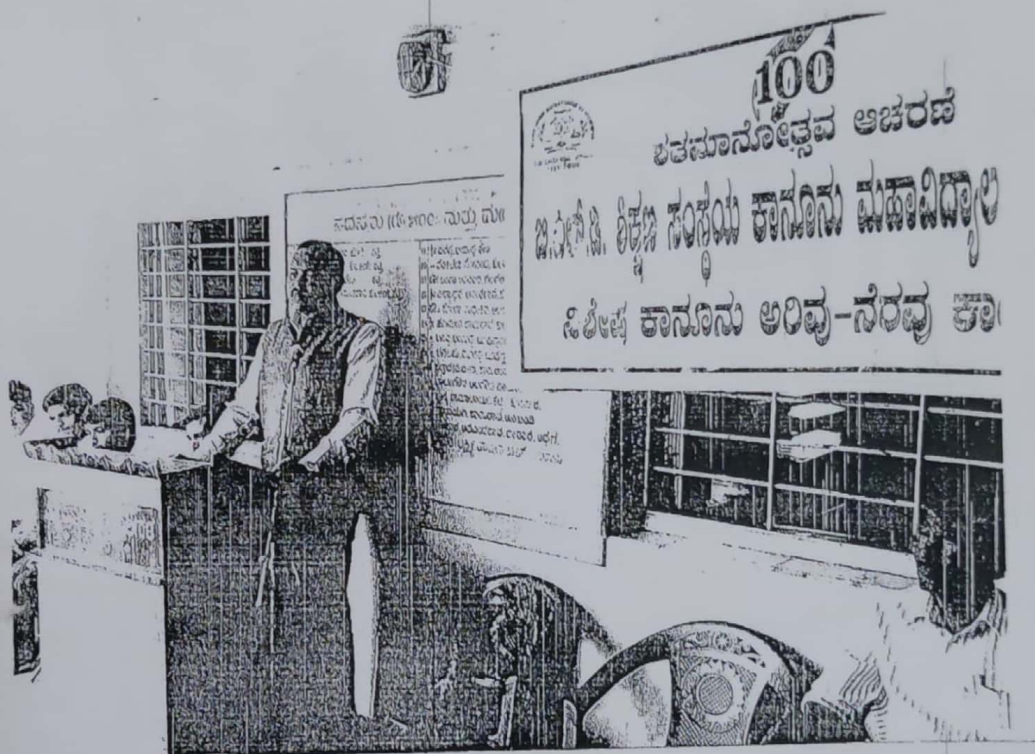

Special Guest Lecture on POCSO Act-2012 on 10.09.2015



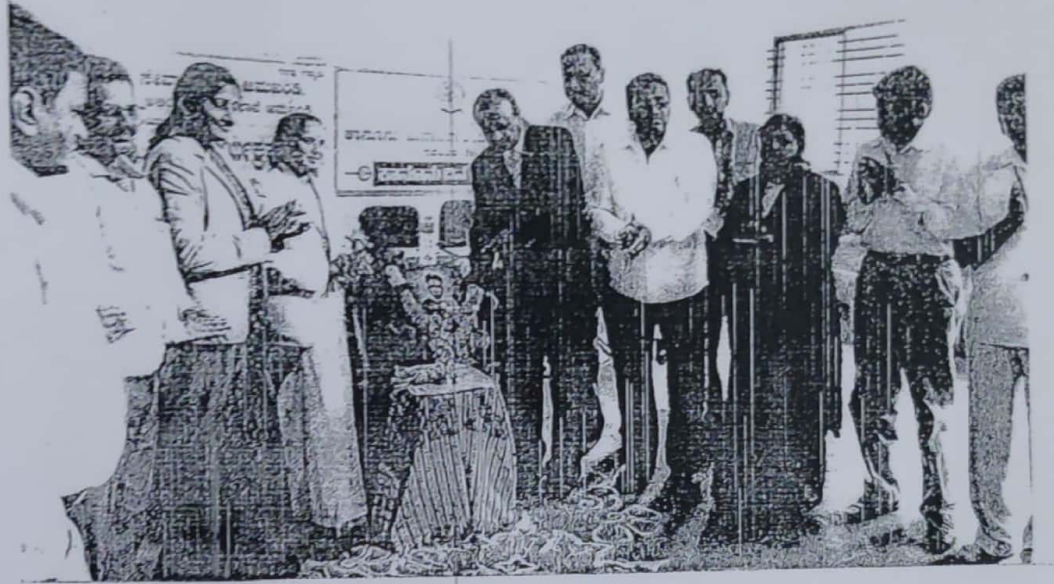
