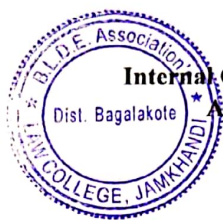

It was also well suggested that, for this year institution has to obtain Certificate for Green Audit. Committee members were agreed and invited the same.

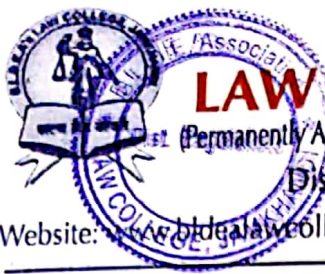

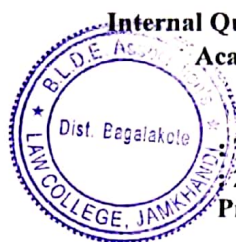
